

SHARP "PRODUCT REVIEW" SWEEPSTAKES

Official Rules

Review must be your own original work and all content that you submit may be used at Sponsor's sole discretion. The Sponsor does not guarantee the posting of any review and reserves the right to reject any Entry and/or review, in its sole and absolute discretion, on the basis that a submitted Entry does not meet the criteria defined below or is otherwise offensive or inappropriate. Qualifying reviews will include a badge indicating you received an

incentive for submitting a review in the Sweepstakes. Entries must be received by 11:59 PM ET on July 31, 2026 to be eligible. All reviews should follow these guidelines: Reviews must be in English only, focus on the product and your individual experience using it and provide details about why you liked or disliked the product. All submitted reviews are subject to Sharp's Customer Ratings and Reviews and Question and Answers Terms of Use, which are included for reference in Exhibit A. In the event of any conflict between these Official Rules and Sharp's Customer Ratings and Reviews and Question and Answers Terms of Use, the terms and conditions of these Official Rules shall prevail. The content of your review will not increase or decrease your chances of winning a prize, however Sponsor reserves the right not to post a review if it contains any of the following types of content or otherwise violates these Official Rules:

- a. vulgar, offensive, sexually explicit, profane or pornographic.
 - b. derogatory of any race, ancestry, place of origin, color, ethnic origin, citizenship, religion, sex, sexual orientation, age, marital status, family status or disability; endorses any form of hate or hate group; defames, misrepresents or contains disparaging remarks about other people, products or companies.

2.
